## Proposed Service

Name of Proposed Service:

*Release of Certain Two Character ASCII Labels*

Technical description of Proposed Service:

*Luxury Partners, LLC, registry operator of the .LUXURY top-level-domain ("Luxury Partners"), hereby proposes an amendment to its Registry Agreement with ICANN, allowing for the immediate release of all two-character ASCII labels that do not appear on the ISO 31661-1 alpha-2 list and for which there is no corresponding country-code operator. Should ICANN approve this proposed service, Luxury Partners will implement responsible measures to introduce these attractive and memorable labels into the marketplace while protecting the interests of any potentially impacted third parties.*

*In addition to mandating that registry operators withhold all two-character ASCII labels from registration or allocation, Section 2 of Specification 5 of the Registry Agreement allows a registry operator to: "Propose the release of these reservations based on its implementation of measures to avoid confusion with the corresponding country codes."*

*Here, Luxury Partners' proposal includes measures to mitigate the risk of confusion. RFC 1591, authored by Jon Postel, formed the foundation for the creation and delegation of country-code TLDs and established that two letter country codes would be derived from ISO-3166. Luxury Partners intends to avoid possible confusion with such country codes by continuing to reserve all two-character labels present on the ISO-31661-1 alpha 2 list. If ICANN grants this proposal, none of the two-character labels released by Luxury Partners would match existing country codes. This commitment precludes existence of country-code-matching labels in the .LUXURY namespace, eliminating the possibility that the names released by Luxury Partners might be confused with existing country codes. Accordingly, ICANN should approve Luxury Partners' request to immediately sanction the release all two-character ASCII labels that do not appear on the ISO 31661-1 alpha-2 list.*

*In technical terms, Luxury Partners proposes to simply make the identified two-character strings potentially available for registration according to the current specifications of the .LUXURY registry. Similar to past approved proposals for the release of two-character labels (including similar requests of .ORG, .ASIA, .TEL, .MOBI, and .NAME), the technical implications of such a request present no risk to the security and stability of the Internet. *Given that none of the labels identified for potential release correspond to a government or country-code operator, Luxury Partners could not directly solicit permission for the release of such strings. Rather, Luxury Partners bases its request on that fact that the release of the identified two-character names (a) does not negatively affect the security and stability of the Internet and (b) enhances the potential success, usage and innovation for New gTLDs by allowing for the release of valuable names into the market, and (c) responds to significant market demand.*

a. If the registry is a sponsored TLD, what were the nature and content of these consultations with the sponsored TLD community?:

*None - The registry is not a sponsored TLD, so consultations with a sponsored TLD community could not occur.*

b. Were consultations with gTLD registrars or the registrar constituency appropriate? Which registrars were consulted? What were the nature and content of the consultation?:

*None - This proposal does not alter the relationship between Luxury Partners and its accredited registrars. \r\n*

c. Were consultations with other constituency groups appropriate? Which groups were consulted? What were the nature and content of these consultations?:

*None - Consultations with other constituency groups were not appropriate.*

*Numerous potential registrants have contacted both Luxury Partners and its accredited registrars, seeking to register two-character domain names. This suggests a high demand from potential registrants and end users for the release of such 2-character labels. \r\n*

*Potential registrants interested in obtaining two-character labels would endorse this proposal. Registrars seeking attractive inventory for potential customers would support the release of these labels. End users hoping to visit websites hosted on short and memorable .LUXURY domain names would approve of this proposal as well.*

List the relevant contractual provisions impacted by the Proposed Service:

*Registry Agreement, Specification 5, Section 2: Two-character labels. All two-character ASCII labels shall be withheld from registration or allocated to Registry Operator at the second level within the TLD. Such labels may not be activated in the DNS, and may not be released for registration to any person or entity other than Registry Operator, provided that such two-character label strings may be released to the extent that Registry Operator reaches agreement with the related government and country-code manager of the string as specified in the ISO 3166-1 alpha-2 standard. The Registry Operator may also propose the release of these reservations based on its implementation of measures to avoid confusion with the corresponding country codes, subject to approval by ICANN. Upon conclusion of Registry Operator's designation as operator of the registry for the TLD, all such labels that remain withheld from registration or allocated to Registry Operator shall be transferred as specified by ICANN. Registry Operator may self-allocate and renew such names without use of an ICANN accredited registrar, which will not be considered Transactions for purposes of Section 6.1 of the Agreement.*

## Contract Amendments

Please describe or provide the necessary contractual amendments for the proposed service:

*Registry Agreement Specification 5, Section 2 should be amended to read as follows: Two-character labels. All two-character ASCII labels specified in the ISO 3166-1 alpha-2 standard shall be withheld from registration or allocated to Registry Operator at the second level within the TLD. Such labels may not be activated in the DNS, and may not be released for registration to any person or entity other than Registry Operator, provided that such two-character label strings may be released to the extent that Registry Operator reaches agreement with the related government and country-code manager of the string as specified in the ISO 3166-1 alpha-2 standard. Upon conclusion of Registry Operator's designation as operator of the registry for the TLD, all such labels that remain withheld from registration or allocated to Registry Operator shall be transferred as specified by ICANN. Registry Operator may self-allocate and renew such names without use of an ICANN accredited registrar, which will not be considered Transactions for purposes of Section 6.1 of the Agreement. For avoidance of doubt, all two-character ASCII labels that do not appear on the ISO 31661-1 alpha-2 list may be made available for*
